The current situation - worldwide and in Germany

Microsoft's Work Trend Index 2024 shows that 75% of knowledge workers globally use AI in the workplace and don't want to wait for it to be officially rolled out or released in the organization.

A study published by Bitkom shows the following picture for Germany:

23% of German companies don't know for sure, but assume that no one in the workforce uses AI professionally. 7% of companies are aware of individual cases.

9% of companies are not sure, but assume that some employees use AI professionally.

28% would like to refrain from drawing up a usage guideline and 48% have not yet dealt with the topic at all, which can potentially entail security risks.

The European Parliament's AI Act

On 01.08.2024, the AI Regulation came into force and provides for a gradual application with regard to the implementation of the individual requirements. The obligation to ensure sufficient AI competence will already apply from 02.02.2025.

"According to the AI Regulation, the aim of ensuring AI literacy is to derive the maximum benefit from AI systems while preserving fundamental rights, health and safety and enabling democratic control. For this reason, providers, operators and data subjects should be equipped with the necessary concepts to make informed decisions about AI systems. that the addressees and operators are in a position to ensure compliance with and enforcement of the AI Regulation and the other relevant legal regulations."

- Lack of competence in the workforce: 41%
- Employee acceptance: 35%
